

# ENROLL IN THE ILARIS® (canakinumab) CO-PAY PROGRAM

#### Eligible patients may pay a co-pay as little as \$30\*

Eligible patients pay as little as \$30 per month, subject to an annual cap. Patients who are insured through federal or state programs are not eligible.\*






### **ONE CARD, MULTIPLE PATHWAYS**

Whether co-pay claims are managed by the office or the patient, there's a variety of ways to access co-pay support for ILARIS®.

#### **HCP-Managed Claims**

If your office will manage co-pay claims, you can initiate enrollment through the **Co-Pay Portal** or the Start Form. Claims can then be managed through the portal or by fax.




Our Co-Pay Program provides the flexibility to manage co-pay claims in multiple ways that fit your workflow, whether through your office or managed by the patient.



#### **Patient-Managed Claims**

If your office is not managing co-pay claims on your patient's behalf, patients are able to pay up front and get reimbursed via the ILARIS® Co-Pay Program. Your patients can manage claim reimbursement in 2 ways:

- Patient Co-Pay Claim Form
- Patient rebate online at Reimburse.patientsavings.com



If you are obtaining ILARIS through a specialty pharmacy (SP) (white bagging), the Co-Pay Card needs to be provided to the SP for them to manage claims.

- Your practice should provide the Co-Pay Card number when sending over the prescription
- The patient can also provide the number if contacted by the SP

#### **HCP Enrollment via the Co-Pay Portal**

- The most streamlined pathway for ILARIS® is the Co-Pay Portal
- If your patient already has a Co-Pay Card number, use the number provided



#### **Patients Who Self-Enroll**

 For patients who self-enroll through ILARIS Companion or a Start Form, claims can be managed by the patient or their HCP
